2013-01 POLICY RESOLUTION NO. RELATING TO REAL ESTATE SIGNS Date Adopted:

WHEREAS, St. Albans Glenn Condominium Association (hereinafter "Association") was created by a Declaration on August 2, 1982 and recorded in the land records at the Courthouse for the City of Virginia Beach at Deed Book 2214, Page 1157 et seq.; and

WHEREAS, the Bylaws for the Association (hereinafter "Bylaws") were adopted on August 2, 1982, and were recorded in the land records at the Courthouse for the City of Virginia Beach, at Deed Book 2214, Page 1190, et seq.; and

WHEREAS, pursuant to Article 3.1 of the Bylaws, all owners of property located within St. Albans Glenn Condominium Association are members of the Association; and

WHEREAS, pursuant to Article 15 of the Declaration, all provisions of the Declaration and Bylaws are covenants that run with the land and bind all Unit Owners within the Association; and

WHEREAS, pursuant to Article 8.1 of the Bylaws, the Board of Directors (hereinafter "Board") is the governing body of the Association and have all powers and duties necessary for the administration and governance for the Association; and

WHEREAS, pursuant to Section 3 of the Association's Rules and Regulations, no signs may be exhibited, inscribed, painted or affixed on any part of the outside of a building or Limited Common Elements or in the windows of any Unit without the prior written consent of the Association; and

WHEREAS, the Board of Directors has deemed it to be in the best interest of the Association to specify when, where, and how real estate signs may be placed upon the common areas without first obtaining prior permission from the Association.

NOW THEREFORE BE IT RESOLVED THAT the following policy be adopted by the Board of Directors:

REAL ESTATE SIGNS

- 1) All real estate signs must contain the address identifying the Unit for sale or for rent.
- 2) Real estate signs may be placed in front of the Unit or at the front entrance of the Association.
- 3) Real estate signs may not be placed in Association landscaping.
- 4) No more than two (2) real estate signs per Unit being sold or rented are permitted. Only one (1) sign may be placed in front of the Unit and one (1) additional sign may be placed at the front entrance of the Association. Such real estate signs may be placed in these locations beginning Friday at 12:00 p.m. until Sunday at 6:00 p.m. when the signs must be removed. RECEIV

5) The Association maintains the authority to remove, without notice, any real estate signs

that are placed or displayed in violation of these rules.
